

## INFORMATION ON THE PROCESSING OF PERSONAL DATA

The present information ensures compliance with the obligation laid down in Article 13 (1) and (2) of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC, hereinafter referred to as the GDPR (OJ L 119, 4.5.2016, p. 1 and OJ L 127, 23.5.2018, p. 2).

2. The Data Protection Officer (DPO) was appointed at the MFA headquarters and in diplomatic missions abroad.

The data are processed on the basis of legality, pursuant to point (a) of Article 6 (1) of the GDPR, with the consent of the person the data refer to for the purpose of the Contest entitled "LOGO CONTEST ON THE OCCASION OF THE 50<sup>th</sup> ANNIVERSARY OF DIPLOMATIC RELATIONS BETWEEN POLAND AND AUSTRALIA", organized by the Embassy of the Republic of Poland in Canberra to the extent necessary to carry out the Contest, draw a winner, attribute a prize and for promotional and informational purposes regarding the Contest, including the publication of the name of the winner of the Contest on the websites and social media accounts of the Embassy of the Republic of Poland in Canberra and the Embassy of Australia in Warsaw.
4. Providing data is necessary for concluding the contract. Failure to provide such data results in the inability to participate in the Contest entitled "LOGO CONTEST ON THE OCCASION OF THE 50<sup>th</sup> ANNIVERSARY OF DIPLOMATIC RELATIONS BETWEEN POLAND AND AUSTRALIA".
5. The personal data will be processed for the period of Contest duration or until the withdrawal of consent. The consent may be withdrawn at any time before the results of the Contest are announced by sending a notification to the email address: [canberra.amb.sekretariat@msz.gov.pl](mailto:canberra.amb.sekretariat@msz.gov.pl). The withdrawal of the consent for processing of the data is tantamount to the withdrawal from participation in the Contest. The data of the winner of the Contest will be stored for archival purposes, in accordance with the provisions of the Act of 14 July 1983 on national archive resources and archives (Journal of Laws of 2020 item 164) and internal regulations of the Ministry of Foreign Affairs.
6. The data will be made accessible to authorized employees of the Embassy of the Republic of Poland in Canberra, as well as to the Contest Committee Members and to the Embassy of Australia in Warsaw.

7. The data will not be transferred to international organizations.
8. You have the right to control the processing of data as set out in Articles 15-19 of the GDPR, in particular the right of access, the right to rectification, the right to deletion and the right to restriction of processing, if applicable.
9. The personal data will not be processed by automated means that will impact on making decision, where it produces legal effects concerning data subjects or similarly significantly affects them. The personal data will not be subject to profiling.
